

# Carol's Creed

(Reviewed February 2022)

Carol's Creed is an annual award, established in 2003, in recognition and remembrance of the outstanding dedication to Canadian Student Services by Carol Jordan, long-time member of the University of New Brunswick.

This award recognizes a student services professional who has shown "infectious enthusiasm" for the profession of services to students through a commitment to health, well being, love, and laughter in their connection with students and colleagues on a personal level.

## The nominee should:

- Demonstrate passion for the profession of student services
- Demonstrate a commitment to health and well being
- Demonstrate a connection with students and colleagues on a personal level

## Minimum Criteria Check

- Nominee must be an AACUSS Member in good standing
- Complete nomination form
- Two support letters from supervisor and/or colleagues (max 500 words each) detailing how the nominee exemplifies the characteristics of the award.
